## DELTA HOTELS BY MARRIOTT TO OPEN IN SEATTLE EVERETT SUMMER 2017

**Everett, WA – April 28, 2017** – Hollander Hospitality announced today its extensive transformation of the Holiday Inn Downtown Everett and its plan to rebrand as one of Marriott International's newest full service brands, Delta Hotels by Marriott. A licensing agreement was recently signed with Marriott International with an opening date expected in summer 2017.
